

## RULES & CONDITIONS OF PLAY

1. All games to be played under the laws of the I.B.A. and I.W.B.A.
2. Tournament games shall be played on the greens of Ward Park & Pickie.
3. Tournament format shall consist of a 'Qualifying' stage of three games, points and shots scored, then progress to a 'Finals' knock out stage.
4. Scoring: Win - 2 points, Draw - 1 point, Loss - 0 points, Bye - 2 points plus shots as average score. Total shots scored shall be taken into consideration. Bonus point for 3 wins.
5. Open Singles shall be 4 bowls each, 12 ends each game. Top 8 qualify.
6. Open Pairs shall be 4 bowls each, 12 ends each game. Top 8 qualify.
7. Open Triples shall be 3 bowls each, 12 ends each game. Top 8 qualify.
8. Open Rinks shall be 2 bowls each, 12 ends each game. Top 8 qualify.
9. Open U18 Singles shall be 4 bowls each, 10 ends each game. Top 4 qualify.
10. Mixed Pairs shall be 4 bowls each, 16 ends each game. Top 8 qualify.
11. Mixed Pairs shall be played on Friday, Wednesday & Thursday evenings.
12. Games in 'Finals' stages shall be 18 ends each game. Except U18's.
13. Trial ends in 'Finals' stages only, consisting of 2 bowls each way.
14. All U18 competitors must be under 18 years of age on the day of the final.
15. If any player fails to appear within 15 minutes of the allocated time the match may be awarded to their opponent.
16. Players competing in the 'Finals' stages will be required to wear Club colours or white for Men and/or creams for Ladies.
17. All winners to make themselves available for the presentation after the 'Finals' have been played.
18. Slow play or misconduct shall be dealt with by the committee as they decide.
19. Tournament times will not be rearranged to facilitate any other Tournament.
20. The Committee have the right to refuse entry to the Tournament, to change dates, to reschedule games, to reduce ends/games and to enforce the rules.
21. Players participating in the Tournament do so at their own risk.
22. Child Protection Officer for the Tournament shall be George Martin.
